## CRVS Applied Research and Training (CART)

### Cohort 2 is opening for applications!

The [CRVS applied research training \(CART\) initiative](#) focuses on enhancing CRVS systems through supporting applied research on strategies, interventions, and tools. This project aims to strengthen the capacity of CRVS practitioners to conduct high quality CRVS related research. Participants will be assigned a topic expert mentor, join online and face to face training, submit deliverables and receive support you through every step of the way: from your initial idea through to submitting a paper and getting your evidence used to improve CRVS programmes. Participants are expected to dedicate significant time to conduct their research.

The first cohort from Asia, Pacific and Africa participated in a face to face workshop in Dubai, United Arab Emirates during 26 to 30 August 2024.

With the first cohort successfully underway, the [\*CART initiative is opening for applications for the second cohort\*](#). The application period is 2 September - 25 October 2024. Applicants will be notified of the outcome of their application by mid December 2024.




### **CRVS Inequality Assessment Project in Indonesia**

ESCAP, in collaboration with Badan Pusat Statistik (BPS-Statistics Indonesia) and supported by the Bloomberg Philanthropies Data for Health (D4H) Initiative, organized an inception workshop to officially launch a project focused on implementing inequality assessments in Indonesia. Held on August 6, 2024, in Jakarta, the workshop brought together approximately 50 participants from key ministries involved in Civil Registration and Vital Statistics (CRVS) systems, including the Ministry of National Development Planning (BAPPENAS), the Ministry of Home Affairs (MOHA), and the Ministry of Health (MOH). Representatives from WHO, the World Bank, UNHCR, UNFPA, and UNICEF also participated in the workshop.

The interactive workshop introduced the project, engaging relevant stakeholders to share best practices implemented at the regency level to enhance the completeness of civil registration. Participants also discussed challenges faced and approaches and data requirements for conducting inequality assessments.

Following the inception workshop, a three-day capacity-building session was held from August 7-9, focusing on the application of various statistical techniques to estimate the completeness of birth and death registrations and to identify those who are left behind across different dimensions of inequality. The workshop was attended by 40 participants, with the majority representing BPS. Additional participants included representatives from BAPPENAS, MOHA, MOH, WHO, as well as intern students at BPS and students from the College of Statistics, which is managed by BPS.



### Report launch: How lack of documentation drives modern slavery

The United Nations University Centre for Policy Research (UNU-CPR), together with the Freedom Fund have examined modern slavery risks among individuals lacking documentation. ### **Enhancing Demand for Civil Registration through People-Centered Campaigns in the Philippines**

The challenge the Philippines is facing in terms of civil registration and vital statistics (CRVS) include the current law that hampers affordable procedures and timely processes. To overcome the challenges and improve the system, the Global Health Advocacy Incubator (GHAI) and the Philippines Legislative Committee on Population and Development (PLCPD), with funding from Bloomberg Philanthropies, have rolled out media and outdoor campaign to support an Omnibus CRVS Bill for a universal, more inclusive and accessible civil registration system. The proposed Bill will make ways for improved accuracy, universality, and inclusivity.

The campaign, dubbed “Get Everyone in the Picture”, sends out a unified message of “universal birth registration for all,” and the messages also encompass all vital events that are essential to ensure the rights of the people and the informed public planning and policies.

### **Indonesia: The UN and BPS met to strengthen collaboration**

The UN Resident Coordinator Office (RCO) in Indonesia organized a courtesy visit and meeting between the UN Resident Coordinator (RC), Ms. Gita Sabharwal, and the BPS (National Statistics Agency) Deputy Chief Statistician of Social Statistics, Dr. Ateng Hartono, SE, M.Si, on August 20th, 2024, at the BPS office. Accompanying the RC were technical staff from WFP, UNEP, UNICEF, UNFPA, Global Pulse Asia Pacific, and UNHCR. The Deputy was joined by the Director of Population and Manpower Statistics, Mr. Ali Said, and his team.

In her remarks, the RC expressed her desire to strengthen collaboration between the UN and BPS, building on previous engagements by individual UN agencies. The Deputy of Social Statistics delivered a presentation addressing the existing and ongoing collaboration between BPS and the UN, which includes strengthening the National Statistical System, improving Data Accessibility and Utilization, Harmonizing Data with International Standards, Developing Regional and International Cooperation, and Monitoring and Measuring Sustainable Development Goals (SDGs).

The UN is expected to assist BPS in preparing for the 2030 population census by optimizing the use of registration data. With the UN's support, BPS is committed to continuing its modernization efforts, including initiatives such as digital demography, the Indonesia vital statistics system, international migration data, dynamic weighting for population surveys, and building a comprehensive data system from the village level up.



### **CRVS Champion: Urvashi Kaushik**

*Our community newsletter puts a spotlight on people who have gone above and beyond in their efforts to support CRVS programmes in Asia and the Pacific, raise awareness of CRVS issues or lead CRVS improvement efforts in their home country or in the region. This month, we would like to dedicate this issue of Insight to Urvashi Kaushik.*

#### **What is your current title and role?**

Presently, I serve as Social Policy Monitoring and Evaluation Specialist at UNICEF India Country Office. I lead our CRVS programme nationally including assisting colleagues in the field doing great work at state level in India.

#### **Can you please share with us a particular experience which highlighted the importance of CRVS to you?**

Personally, the most moving experience on birth registration was when we received the birth certificate of our son with our names as his parents after going through a long adoption journey and knowing that the baby is finally and fully ours. Incredibly, the certificate arrived when I was on a CRVS mission in Dhaka in June 2023 with all the South Asian country governments discussing progress on the CRVS Decade of Action!

Working in the Indian state of Bihar and now nationally, my professional experience on CRVS constantly inspires me to confront the complexities of the challenge, appreciate the collaborative efforts of a range of stakeholders to strengthen CRVS systems, and recommit to our contributions to ensuring all children everywhere realize their first right – the right to birth registration.

#### **How are you currently involved in CRVS improvements?**

At UNICEF, we support government programmes to strengthen CRVS systems through technical assistance, capacity building, and data interventions working jointly with partners in government, academia and civil society, and the UN. India has seen tremendous

progress in coverage of birth registration services driving further sustained efforts to achieve 100 percent birth registration and certification.

### **Which advice would you give to others trying to improve CRVS systems?**

Three things. One. Perseverance is key, and we must keep up the passionate action. Two. To universalize civil registries, we must focus on the excluded groups. Three. None of us can do this alone so reach out and expand the partnerships base!
