### How are CRVS systems responding to the COVID-19 crisis?

As referenced in our <u>April edition of CRVS Insight</u>, the UN Statistics Division developed a short survey for National CRVS focal points to assess the impact of the global pandemic on the functioning of civil registration worldwide, as well as provide information regarding national solutions. In Asia and the Pacific, the questionnaire was distributed by ESCAP to National CRVS Focal Points.
