

# Historical Development

- Marriage Registration Act, 1971
- The Births, Deaths and Other Personal Events(Registration) Act, 1976
- The Births, Deaths and Other Personal Events(Registration) Regulation,
  1977
- Implemented in different phases (10 districts from 1977- universal in 1990)
- Internal migration and divorce included in 1983 and 1985 respectively.

#### Cont...

- Institutional responsibility was changed time to time (Ministry of Home Affairs- Ministry of local development-Ministry of Home Affairs).
- Established Department of Civil Registration in 2014
- Merged Department of National ID and Civil Registration in 2019
- There were around 4000 (3915+58) Local registration offices before 2015.

# Legislative Framework

- The Constitution of Nepal
  - Rights of the child: "Every child shall have the right to name and birth registration along with his/her identity"- article 39
- National ID and Civil Registration Act, 2020 and regulation, 2021
  - Notification, verification, registration and certification
- Strategy of Civil Registration and Vital Statistics (CRVS), 2019
  - Civil registration and vital statistics detail action plan with time line and responsible agencies.
- Civil Code, 2017
  - Provisions related to natural person, marriage, adoption, guardianship, etc.
- The Act Relating to Children, 2018

## Organizational Setup

- The Department of National ID and Civil Registration (DoNIDCR), under the Ministry of Home Affairs (MoHA)
  - Director General acts as a central registrar
- The local registrar's office: 6,743 and 15 diplomatic mission abroad.
  - The local registrars are authorized to register and issue the certificates and perform registration-related tasks like amendments and issuance of certificate copies.

#### National CRVS systems coordination mechanisms

- National Coordination Committee is chaired by: Secretary, Ministry of Home Affairs
- Strategy implementation unit is chaired by: Director General,
  Department of National ID and Civil Registration

# Integration and coordination

- DoNIDCR manages the Vital Event Registration and Social Protection
  Management Information System (VERSP-MIS) for the centralized
  online civil registration.
- VERSP MIS is integrated to many government MIS systems (NID, NSO, Department of Immigration, CIMS, HMIS etc.)

#### Integration and coordination

- NSO and DoNIDCR have been working to publish CRVS report jointly.
- DoNIDCR is conducting inequality assessment of CR with the collaboration of UNICEF.

# Challenges

- Network connectivity for remote area
- Lack of awareness of the public
- Late registration
- Low registration rate
- Capacity gap specially in local level
- Coordination with multi sectorial agency
- Partial need of vital registration documents for service delivery

### **Next Steps**

- Increase coverage of registration
- Authorizing and implementing CR completeness standard
- Implementation of online CR in remaining wards (51)
- Establishing link between Census and registration data and Publishing automated disaggregated vital statistics report
- Use of CR data for public services.
