Progress on CRVS activities

Bangladesh has achieved all implementation steps except inequality assessment of RAF.

Office of the registrar general (ORG) has a plan to implement the monitoring and reporting plan.

The CRVS++ policy and CRVS system architecture was defined.

National CRVS Coordination Mechanism;

In 2019 births registered estimated 22% and deaths registered 33%.

All individuals are provided with birth and death certificate immediately after the registration completed.

MCCOD scaled-up in 122 hospitals (Govt-77, Private-45) up to 2020 in all over the country.

VA pilot scaled up in 13 sub-districts of different Districts in 2019.

Law and Justice Division has taken initiatives to introduce online the marriage and divorce registration.

Action taken to strengthen the CRVS System

Political Commitment

- Strong political commitment including from the Minister of the Local Government Division.
- Active engagement of local leaders.
- Bangladesh has prioritized strengthening its CRVS system.

Policies, legislation and implementation of regulations

- Birth and Death Registration Act 2004 and Rules, 2017.
- Registering births and deaths within 45 days of the event became law.
- Conducted a legal review on CRVS related laws.
- Developed the Birth and Death process mapping (Enterprise Architecture).
- Total 5082 local register office are conducting online birth & death registration.

Action taken to strengthen the CRVS System

Linking CRVS with other national system

- Introduced Unique Id at birth and to establish interoperability with other agencies.
- BDRIS System linked with NID and will link to DHIS2
- BDRIS will link with family planning eMIS, primary education system and secondary and higher secondary system very soon.

Public engagement, participation and generating demand

- Generating public demand for registration
- Raising awareness about the benefits of registration
- Introducing congratulatory letter for birth and condolence message for death
- Engaged Health Sector to Improve the Civil Registration of Births and Deaths. (Kaliganj Model)

Monitoring and Supervision

- Monitoring the real time progress on birth and death registration
- Strengthening monitoring and supervision at sub district level
- Introduced Birth and Death registration target in District and Sub-district level Annual Performance Agreement (APA).
