# Concept Note for World Café on key messages in the 2025 Ministerial Declaration (building on discussions in Session 15)

## Timing:

09.30-10.35, Thursday 9 May 2024

### **Format**

The "World Café" format is a meeting process that involves a series of simultaneous conversations around a particular issue or topic. This World Café session will last for roughly 60 mins and consist of a series of table conversations involving 8-10 persons per round table. Each table has a "host" and/or an ESCAP resource person. During the course of the World Cafe, participants may change tables several times and discuss different aspects of the same general topic (key messages in the 2025 Ministerial Declaration) with a variety of other participants, delving more deeply into the topic during each subsequent conversation. This enables ideas to flow around the room and participants to connect with a larger group of individuals and hear new perspectives. Through this process, participants are able to identify common themes or common ground in response to each question.

The process starts with the first of three or more discussion rounds for the small group seated around a table. At the end of each discussion round, participants may wish to move to a different table.

The table hosts and/or ESCAP persons should stay at the table throughout the different rounds of the discussions. The table host or ESCAP person welcomes new guests, briefly summarize the previous conversations, and motivate further discussion. The ESCAP persons can help with the preparation, notetaking and reporting back.

As well as speaking and listening, individuals are encouraged to write or draw on the post-it/sticky notes and place them on the flipchart so that when people change tables, they can see what previous members have expressed in their own words and images. Colourful pens on the tables and a plentiful supply of blank paper provide the opportunity for participants to write down the keywords, phrases, images, and symbols that reflect ideas emerging in their conversations. Participants are encouraged to tick or underline any ideas or issues to which they can relate.

# Feedback and output

Each round lasts 15-20 minutes and participants may wish to move to a new table to join their discussions. At the end of the World Café, there will be a long list of insights on key achievements throughout the Asia and the Pacific CRVS Decade. Table host or ESCAP person will be asked to summarise the top three to five ideas related to the table topic on the table so others can move around and see the different ideas.

#### **Role of Table Hosts**

As a table host you will need to:

- Give a one-minute lightning presentation on the discussion topic which your table will be looking at (as this is very short, we will not be using PowerPoint slides);
- Welcome people to the table and then help to facilitate the discussion;
- Encourage participants to talk and also to write down ideas on the post-it/sticky notes to be placed
  on the flipchart, and build on each other's ideas; they may want to put a tick by ideas they agree with
  or a cross if they disagree;
- Participants may wish to move to a new table every 15 to 20 minutes;
- As new people come to the table, you may want to summarise the discussions and then encourage them to build on the earlier discussions. Please also encourage them to keep writing down their thoughts;
- Table host or ESCAP person at each table will report back during the feedback session;
