# **Outline of CART curriculum and timeline**

### **<u>Time required</u>**

Please note that each topic will consist of one recorded lecture of between 30-60 minutes with office hours with the facilitators provided each week. Lectures will be available for participants to watch at their convenience and an interactive platform for Q&A and sharing materials will also be available. Two options for offices hour will be available to accommodate different time zones and schedules, envisaged that one session will take place in the morning Bangkok time and the other will take place in the late afternoon Bangkok time. Office hours will provide an opportunity for participants to discuss with facilitators and other participants.

It is anticipated that participants will spend 10-15 hours on classwork and homework each month. There will be three mandatory online live sessions of 60-90 minutes each and two face to face workshops of one week each (location to be determined but expected to alternate between Addis Ababa and Bangkok). Attendance at these is required.

- b. Appraising study design, participants, generalizability (May 7)
- c. Appraising methods, analysis, bias and confounding, results (May 8)
- d. Appraising applicability and interpretation, relevance to policy and to proposed study (May 13)
- e. Creating a hypothesis (May 14)
- f. Informed consent, ethical research design and methods, conflicts of interest and peer review, seeking ethics approval (May 15)

Deliverables (by May 27): literature review, updated research question and hypothesis, ethical review

- b. Identifying variables and measurement and drafting a conceptual framework (June 4)
- c. Selecting and evaluating data sources (June 5)
- d. Data collection methods (June 10)
- e. Sampling design and strategy (June 11)
- f. Analytical framework and data analysis plan (June 12)

Deliverables (by June 24): Conceptual framework, initial research proposal, including data source overview and elements from all three modules.
